

PUBLIC NOTICE
OF THE HEARING ON THE APPLICATION OF VOYAGER AT WHITE
MOUNTAIN LAKES WATER COMPANY, INC.
FOR APPROVAL FOR AN EMERGENCY RATE INCREASE
(DOCKET NO. W-01983A-23-0166)

Summary

On June 23, 2023, Voyager at White Mountain Lakes Water Company, Inc. ("Voyager") filed with the Arizona Corporation Commission ("Commission") an Emergency Rate Case Application ("Application"). In its Application, Voyager requests authority to implement an Emergency Rate Surcharge to collect \$302,658 annually to pay for the services of a certified operator for the system following the death of its former owner, to pay for system repairs and upgrades, and to pay past due Arizona Department of Environmental Quality Monitoring Assistance Program invoices.

THE COMMISSION IS NOT BOUND BY THE PROPOSALS OF VOYAGER, STAFF, OR ANY INTERVENORS. THE COMMISSION WILL DETERMINE THE APPROPRIATE RELIEF TO BE GRANTED IN RESPONSE TO VOYAGER'S APPLICATION BASED ON THE EVIDENCE PRESENTED IN THIS MATTER.
